The CSCE aims to meet the needs of the communities it serves and its clients by building on a set of values such as commitment, integrity, collaboration, excellence, accountability and compassion.

Youth wellness hub is a unique integrated service point for young people aged 12 to 25. A place where they can find health and wellness needs, including mental health, addiction behaviours, primary care, and social and community services.

WHAT TO EXPECT ?

- Perform clinical tasks by performing physical examinations, triage assessments, diagnostic history reviews, treatments (including pharmacological/prescription drugs) and requests for laboratory tests, x-rays, and ultrasounds, according to the expanded exercise framework.
- Assess patients to identify physical and/or mental health needs to determine appropriate interventions.
- Collaborate with members of an interdisciplinary health team to plan, implement, coordinate, and evaluate patient care in consultation with patients and their families.
- Ensure appropriate and comprehensive treatment is provided to Hub clients by maintaining complete and accurate records and participating in case discussion in a multidisciplinary team.
- Work with youth with diverse health issues, primarily mental and sexual health, but also other primary health issues.
- Innovative and evolving service for a vulnerable community with barriers to access to health care.
- Asset: Interest in youth, training or experience working with youth, and willingness to take training (paid for by the employer) to further their knowledge and recommended intervention techniques.

- Bachelor's degree or master's degree in sciences of nursing + 2nd cycle specialization to practice as a nurse practitioner in Ontario.
- Experience in working as a nurse practitioner.
- Experience in primary care in a hospital or community setting.
- Experience with electronic medical record (PS Suite an asset)
- Thorough knowledge of physical examination methods and investigative tests
- In-depth knowledge of current treatment options for primary care nurse practitioner practice
- Knowledge of basic ethical rules
- To be able to advise clients.
- Ability to work with multidisciplinary team.
- Clinical judgment behavior, discretion, autonomy, flexibility, and effective interpersonal relationships
- Excellent verbal and written communication skills in French and English
